Membership Application and Agreement for Renew Life IV Infusion & Injection

This Membership Application and Agreement ("Agreement") is made by and between the undersigned ("Member") and Renew Life IV Infusion & Injection ("Association"), regarding the Member's application for membership in the Association.

- 1. The Association is committed to creating a platform where members can engage in private business transactions with the Association and fellow members. - 4. **Rights and Freedoms**. Members of the Association agree to abide by a Confidentiality Agreement and refuse to disclose confidential or proprietary information of the Association with any individuals outside of the Association. Members of the Association may use confidential information to fulfill the mission of the Association but acknowledge that any breach of confidentiality with an individual outside of the Association may result in significant harm to the Association and may result in disciplinary action, including revocation of membership. The Association also agrees to maintain a strict vow of confidentiality agreement regarding the internal operations of the Association, including any and all financial statements.
- 7. **Non-Discrimination Clause.** The Association will acknowledge as a Member anyone who meets the above-mentioned requirements, regardless of their age, race, color, gender, or ability. The Association will provide a platform for members to interact with one another and work towards fulfilling a common mission for the good of the Association.
- 8. **Termination of Membership.** Membership to the Association and any of its groups is subject to termination by the Association Trustees or their designee, without prior notice, if it is determined that a member's behavior or interactions with other members are not aligned with the Association 's focus, principles, and goals, or are causing harm to the Association or its members. The decision to terminate membership will be made at the sole discretion of the Trustees, and shall be final and binding. The Association retains the right to take necessary action to protect its interests, members, and reputation, and to ensure a safe and respectful environment for all. Both parties may terminate this Agreement, for good cause, the Member reserves the right to terminate Membership at any time by submitting a notice of termination in writing to the Trustees within (30) days.
- 9. Notice of Limited Liability. The Association and its members shall not be held liable for any damages, losses, or injuries incurred by individuals who participate in activities or events, except in cases where such damages, losses, or injuries are caused by the Association or its members' willful misconduct or gross negligence. This limited liability provision is intended to protect the Association and its members from undue legal exposure and does not affect the Association's commitment to providing a safe and secure environment for its members and visitors.
- 10. **Agreement.** I am becoming a member of Renew Life IV Infusion & Injection, a Unincorporated Private Health Association, under common law, to support other members in achieving spiritual, mental, and physical wellness. By joining, I agree that my involvement with the Association is private and confidential, and will not disclose any private matters to the public.
